Education Grant Criteria: for a **Secondary School or Maori Equivalent**

1. The applicant must be a parent/guardian of the student/s
2. The APPLICANT must show that they are an owner, a descendant of an owner, or a beneficiary of a Whanau Trust that holds shares in the Te Hanga South Trust by producing a verified copy of their whakapapa signed by an owner or kaumatua.
3. Where there are more than one student of the same whanau attending the Secondary School their costs can be included in this application as well
4. Where more than 1 whanau member attending **Secondary School** is included in this application a total **not exceeding \$1000** per whanau will be considered
5. The student/s must be enrolled **and attending**, a Secondary School or Maori Equivalent that is registered by the Ministry of Education in New Zealand
6. Applicants must produce verification of their attendance
7. Applicants must provide a copy of the School fee and/or uniform invoices/quotes
8. If applying for specialist technology equipment necessary for study course OR special sporting equipment, **two quotes** are required
9. If applying for an Educational or Special Sports visit appropriate documents outlining dates and events must be provided **AND** confirmed by a person of authority such as the principal or staff member in charge of the visit
